All partners have the intention to maintain cooperation and communication after the project completion in order to further update the solution proposed by this project and to develop new tools, instruments, digital resources for creating innovative educational materials that can be implemented at European level. The partners will capitalize the experience and expertise gained during this project by elaborating and implementing new projects and will allocate the necessary resources to cofinance those projects. The Exploitation plan, when implemented will ensure the sustainability of the outcomes and will continue to reach its target groups by: continuing the projects social media, website and content sharing media - continuing to reply to any party interested in obtaining the project's results - continuing with the partnership to support dissemination of the project output in future events after the end of the project such as conference events, newsletters of their organizations, email alerts and signatures, etc. - future updates on the European platform of videos (O1) - continuation of the promotion of the project's outputs through the sustained (at least 3 years after project ends) project's website - partners promise to continue
